2006 Elections -

Governor-

Cliff Thorton has started collecting petition signatures to qualify for the ballot as Green gubernatorial candidate. He has shifted gears from his advocacy work at Efficacy to electoral work. He would be a substantial candidate and the first African American candidate for governor. We should invite him to winter forum. He has been endorsed by numerous chapters, including New London & New Haven.-

39th State Representative Race (Ernest HewittÕs seat)-

Allyn DeVars has contacted both Republican & 1 New London town chairs and received no response. If we don't run candidate we have no ballot access. Laura Cordes suggested we have special meeting to see what we should do. The petitioning deadline is August 10th.-

Broadwater (Laura C) -

Forum will take place at New London High School Auditorium. It will feature a press conference with Geoff Kaufman, Attorney General Blumenthal, and State Senator Andrea Stillman. There will also be a panel discussion featuring Lonnie Reed, CT Fund for the Environment, Adrian Esposito from New York anti-Broadwater group, and others. Broadwater has submitted proposal to Federal Energy Regulatory Commission. The goal of forum is to spark anti-Broadwater organizing. New London has not yet passed a resolution against Broadwater. -
