Meeting was called to order by Mirna at 7:15pm.

- 1) May minutes: Ronna moved to approve, 2nd by Bob; passed unanimously. June minutes: Mirna moved to approve, 2nd by Wasaka; passed unanimously.
- 2) Treasurer's report: Expenditures were \$25 (use of FRESH urban farm for June meeting); revenue was \$491 (from June 16 yard sale). Current balance is \$816.09.
- 3) State Central Committee report:
 - (a) The State Central Committee met on June 27; work on approving a budget and seeking candidates is ongoing.
 - (b) in lieu of a business meeting in July, a candidate meet-and-greet will be held on Wednesday 8/25; all are welcome to attend.
- 4) Old business
 - (a) 2018 elections report from June 30 nominating meeting <u>2nd Congressional District</u>: Michelle Louise Bicking and Cassandra Martineau sought the nomination; Michelle was the winner of the paper ballot vote. <u>55th district, CT Assembly</u>: Rob Barstow was endorsed unanimously. <u>Windham Registrar of Voters</u>: Cassandra Martineau was endorsed unanimously.
 - (b) Potential issues and projects, continued

<u>Body Cams</u>: funds were allocated years ago, but camera purchase was not implemented; as a result, New London is out of compliance with the Penn Act. Potential allies include NAACP, GRACE, Hearing Youth Voices, NL Clergy. <u>Single-use plastic ban</u>: we should check status of Waterford effort Support nonprofit <u>Sleeping Giant Energy</u> to be NL's energy development agent

- 5) New business
 - (a) Mar has resigned as NLGP secretary; we will seek a replacement, but Ronna is willing to be temporary recorder.
 - (b) Fundraiser idea: Sell Cummings & Goode prints/posters, which they have offered to donate upon dissolving their office; Pride Fest (August 25) may be good venue.
- 6) Updates
 - (a) Education and the Board: BOE has applied for a non-lapsing fund to be used on needed Harbor School roof repairs; though rejected in the past, establishment of fund would encourage savings and allow renovations to be implemented.
